- Deadline for Application: SEPTEMBER 1<sup>st</sup>, 2021. (BOOTHS ARE STILL AVAILABLE!)
- Application, Booth Fee and 3 pictures of artisans work and/or previous booth displays(or link to website or social media) is due upon application request. Madison Merchants Guild reserves the right to accept or deny any vendor.
- 10' x 10' Booth...\$50.00. Vendor may rent up to four (4) Booths.
- No Tents, Tables, Chairs or other items/services will be provided by the event. The Vendor is responsible for all necessary materials needed at their booth space.
- All tents need to be weighted down. The tents cannot be anchored onto the road.
- All setup must be completed by 9:00am. A setup time and space # will be assigned to Vendor upon Acceptance to participate in event. Vendor must unload, park vehicle and then setup booth. NO parking on street will be allowed while setting up.
- No Vendors will be allowed to pack up before 5:00pm.
- No Show Vendors will not be allowed to vend or participate in subsequent events.
- Rain Date is October 23<sup>rd</sup>...No Refunds will be issued if Vendor is unable to participate.
- No Dogs (registered Service Animals only).
